A Board of Directors Meeting was held at the Richland Red Lion Hotel on Saturday, July 23, 2011. Financial Report

Treasurer Connie O'Neil distributed a financial accounting report to all in attendance, which was read by Vice President Pete Overdahl. There is \$21,790.25 in the Club 40 checking account, and \$52,096.59 in the Scholarship Fund. A detailed Profit & Loss Statement was furnished to the Officers.

President Zimmer announced that current Treasurer Connie O'Neil has resigned the position. Former Treasurer and current Database Manager Ann Thompson then agreed to resume being Treasurer in addition to continuing as Database Manager. Ann was given a round of applause and Connie received grateful thanks for all her work this past year.

Scholarship Committee

In the absence of Chairman Larry Harrold, who was unable to attend the Board Meeting, Committee Member Pete Overdahl reported that what started with the donation of old RHS Yearbooks by the daughter of former Richland School Board Member Grover Dawson, has been a very successful program to sell those yearbooks and others that have been donated for the benefit of the Scholarship Fund. To date, \$1,000 has been raised.

President Zimmer announced that after serving as Scholarship Committee Chairman for the past four years, Larry Harrold has submitted his resignation. Larry conceived and developed the entire scholarship award program, together with duties, timelines, and goals. The scholarships for 2011 have already been awarded. Larry has set up the program so that someone else can take over without interruption. President Zimmer asked for names of possible candidates to fill this position. Allyson Dennis '67, expressed an interest in meeting with the committee for more information.

Note: At a Scholarship Committee Meeting held immediately after the Board Meeting, Allyson Dennis was approved by the Committee and accepted the Chairmanship. All current members will continue to serve on the Committee.
