Scholarship Report

Chairman Duke Mitchell said that at our April 22, 2017 meeting, Jim Chubb '50, had suggested we consider awarding a vocational scholarship in addition to the four educational scholarships we currently award. It was agreed this would be considered at a future Board Meeting. Duke said Jim Chubb has done some research in this regard, and asked Jim to report further. Jim stated his research has been through Walla Walla Community College, and suggested we consider the Colleges' selection standards. Jim agreed to get additional information, and Duke recommended we consider this.

A motion was made to accept the results of the mail-in ballot, which preferred the Red Lion at Columbia Center as the location for the 2018 Annual Meeting. The motion was seconded and passed.

New Business

Nominating Committee Report and Election of Officers

In the absence of Committee Chairman Dan Haggard, Connie O'Neil was asked to report on the nominations for Club 40 Officers for 2017-2018. Connie reported that all current officers agreed to run again, and that no additional names had been suggested. President Holeman then called for nominations from the floor, but there were none. A motion was then made that we have a voice vote rather than written ballot. The motion was seconded and passed. All current officers were re-elected.

Fall Board Meeting

President Holeman suggested the Fall Board Meeting be held on Saturday, October 7, 2017, from 1:00 t o 3:00 pm, with the location to be determined. A motion to this effect was made, seconded and passed.
